On the basis of the resolution made by the Executive Members of the WBNC in its 204<sup>TH</sup> General Body Committee Meeting held on 26<sup>th</sup> July 2024 it is hereby being notified that -

1. A candidate who has appeared at Council Examination in December-2024 may apply for online Post Publication Review (PPR) / Post Publication Scrutiny of his/her answer scripts(s) within the period from 21 / 03 / 2025 To 04 / 04 / 2025 subject to the provision as laid down herein under.
2. All PASSED Candidates may apply for PPS.
3. All FAILED Candidates may apply for PPS or PPR.
4. Application for PPR / PPS shall be restricted to Theoretical Paper(s) only. (A candidate can't apply both for PPS and PPR in a particular subject.)
5. An incomplete or incorrect application for PPS / PPR shall summarily be rejected by the Council and no correspondence shall be entertained in this regard. No request for refund of application fee shall be entertained.
6. Council shall not accept any application in Manual Form for PPS & PPR and also from individual candidate(s).
7. The entire application process, through online, shall be done by the School only.
8. The Re-evaluation marks will be the Final mark scored by the student - be it more or less than the marks before Review or Scrutiny and a fresh mark-sheet will be issued on surrender of the previous mark sheet.
9. HARD COPY for PPR / PPS and copy with Mark-sheet/s must be submitted to this Council within 11-04-2025 date with the sign and office seal by the Nursing School Authority.
10. Results of PPR / PPS shall also be communicated through mail to the concerned institution(s) by the Council.

PPS (SCRUTINY - It means checking the recording and addition of all marks that determine the result to confirm that all parts of the Answer Scripts have been evaluated and marked and no error occurred in reading/combining/collating/totalling marks.)

PPR (REVIEW - it means Re-evaluation of the entire Answer Scripts by the Council appointed Reviewer(s).

For submission of hard copy of forms, fees are to be paid by SBI Collect Only.
