- 1) VERIFICATION OF ORIGINAL DOCUMENTS WILL BE CONDUCTED ON & FROM 01<sup>ST</sup> OCTOBER 2020 TO 31<sup>ST</sup> DECEMBER, 2020. THE CANDIDATES ARE BEING DIRECTED TO ATTNEND THIS OFFICE & TO PRODUCE ALL THE BELOW ENLISTED ORIGINAL DOCUMENTS WITHIN THE ABOVE SPECIFIED DATE:
- 2) REGISTRATION CERTIFICATE OF THE PARENT COUNCIL WITH ITS RENEWAL UP TO DATE. THE CANDIDATES WITH MULTIPLE REGISTRATION, MUST ENSURE THE CANCELLATION OF THE REGISTRATION CERTIFICATE OF THE PREVIOUS COUNCIL AND MUST PRODUCE A SUPPORTING DOCUMENT FOR THE SAME.
